

We would like to thank you for attending the WISSOTA 100. As an RV guest of I-94 Speedway and WIS-SOTA, please be advised of the following rules and regulations to ensure that you have a safe and memorable stay.

Failure to abide by these rules will result in your spot being revoked and returned to the "available" pool.

Camp Sites

• All camping spaces must be occupied by either an RV, a travel trailer, or a tent.

• Only one (1) additional car is allowed per RV spot. Do not block roadways or your vehicle will be subject to being towed at your expense.

• I-94/WISSOTA reserves the right to reassign camp sites if needed. This policy has been implemented to accommodate the increasing demand and limited supply of camping spaces.

Motorized Vehicles

• All motorized vehicles must be registered and approved decal with vehicle ID number must be affixed in plain sight on the vehicle. You must be 16 years of age or older to operate any motorized vehicle on speedway grounds or within city limits.

• All motorized vehicles must have lights turned on when operated after dusk/dark.

• If you are determined to be operating a motor vehicle in an unsafe or unapproved manner, or in a restricted location, or in any way that endangers other individuals or any property, your registration may be revoked and a fine may be issued to you, and a penalty may be assessed to the race car with which you are associated.

• Due to space limitations, registered golf carts, ATVs, UTVs, scooters, etc. can only be parked in the following areas: 1) the owner's pit area, 2) a designated marked area off turns three and four, or 3) the north grandstand ATV parking area located near the tailgate entrance.

Campfires

• Fires are allowed only in approved above-ground containers. All fire containers must adhere to the Fergus Falls Fire Department code.

• No burning of unapproved materials including but not limited to tires and fuels. If it is discovered that you are burning unapproved or unsafe materials, a fine may be issued to you, and a penalty may be assessed to the race car with which you are associated.

Pets

Campers are allowed to bring a family pet to I-94 Speedway, but it is important that you read and abide by the following rules:

• All dogs must be under control and visual observation of their owner at all times. No dog should be left unattended outside at any time or day or night. We enforce a leash rule at all times for the safety of your pet and all individuals on the grounds.

• Aggressive dogs of any breed are not allowed or permitted in the campground. If your dog shows behavior that is protective and unfriendly to strangers, please leave it home or you may be asked to leave.

• Allowing your pet to bark uncontrollably day or night will not be permitted, and in such event you may be

asked to leave. Service dogs are welcome but you must follow standard leash restraints policies and the dog may not exhibit aggressive behavior, or you may be asked to leave.

- · Campers must clean up after their pets and properly dispose of waste.
- Pets are not allowed in the grandstand area.

Additional Rules & Policies

- No firearms, dangerous weapons or fireworks permitted.
- No soliciting or commercial sales permitted.
- RV and car permits/decals must be affixed to windshield/proper location at all times.
- Vehicle and camping equipment (attached awnings) must not extend beyond assigned space.
- Quiet time will be enforced from 11pm until 7am or beginning one hour from last event conclusion.
- The speed limit on the grounds is 10 mph. This includes all ATVs, UTVs, golf carts, scooters, etc.
- No oversize flatbeds, box or cube trucks will be permitted.
- Please place all trash in trash bags and deposit in speedway containers.
- I-94 Speedway and WISSOTA are not responsible for lost, damaged or stolen property.
- It is strongly recommend that all RVs have a stack pipe for generator exhaust, which contains carbon monoxide gas.
- Camping is an outdoor experience; therefore, we do not give refunds due to discomforts of nature.

Prohibited Items

If you witness others with any of these items, please report to the office at (218) 998-2191:

Beer balls, drones, fireworks, glass containers, illegal drugs, laser pointer, scaffolds or platforms unless approved, stadium seats wider than 17 inches, stadium seats with arms, weapons of any description including guns, knives, ice picks, etc. regardless of permit, or other items that may pose a safety hazard or diminish the enjoyment of the event for other patrons.

Prohibited Activities

The following activities are not permitted on speedway grounds, except in the case of approved individuals and commercial vendors:

- Solicitation or distribution of any merchandise, products, services or donations.
- Selling or buying of event tickets.
- Distribution of advertising or promotional materials for non-WISSOTA sanctioned events.
- Destruction of any part of the grounds, wetlands, or speedway property.
